## ISSUES BRIEFING IS THE FOUNDATION OF LOBBY DAY

The Issues Briefing Day in early October was highly successful. Attending were 38 League members from Ames, Black Hawk-Bremer, Cedar Rapids-Marion, Grinnell, Hamilton County, Jasper County, and Metro Des Moines.

Two issues covered at Issue Day will be pursued with legislators. First, two young men spoke on Predatory Pay Day Lending. They had a powerful power point presentation that illustrated the changes that have taken place in debt levels for citizens in the last 20 years and more. They were very well prepared and gave an engaging talk. They are also available to give talks to local leagues who request the presentation. The materials they included contain information on Predatory Lending background, talking points and the current status of this issue.

Representative Mark Smith, 2010 Chair of the House Human Resources Committee spoke about "Improving Iowa's Mental Health System." He has been a mental health professional since 1988. In his talk he spoke about some of the history of mental health in lowa including the contributions of former Governor Hughes, later Senator Hughes, including in 1972 the Substance Abuse Treatment Act which Senator Hughes took national. Smith has introduced a mental health parity bill each year of his service in the house. Written handouts included current status of mental health, background material, talking points, and current status of legislation for 2011.

Gun registration and voter ID requirements will be the other two issues discussed with legislators.

In 1999, JoAnne Finkenbinder and I organized a Black Hawk – Bremer League forum on sentencing issues in Iowa. Then Chair of the Department of Corrections presented a power point on the dilemmas facing the DOC due to sentencing. These issues were then addressed by a police officer, a prosecutor, a judge, a community corrections officer, a board member from the DOC, and a criminologist. The meeting made the front page headlines of the next day's Waterloo Courier - from then on, I was hooked on League! That meeting eventually led to a statewide study on sentencing and the positions currently taken by the LWVIA. I switched jobs as a school psychologist in 2003, moved to Des Moines, and joined the Metropolitan Des Moines League. In 2008 I became the president for my local and completed my two-year term just this spring. I am now semi-retired and looking forward to helping on the LWV IA Board.
