Treasurer Report

Treasurer L. Meloy presented the Balance Sheet and the line items Budget have sheets. Total Checking is \$5,376.47 and LWVIA EF \$1548.94. A gift of \$955 in stock has been given to the 19th Amendment Committee.

All Leagues will have paid PMP, once Ottumwa's payment is received.

The IRS has not yet listed LWVIA as a 501c3. LWVIA can receive the \$750 gift to ED Fund from Judie Hoffmann estate's matching grant when IRS lists us.

The Office Supplies line item is over budget, due to the order of LWVIA notecards that are to be shared with local Leagues. Contact L. Meloy for a supply of notecards.

Meloy shared a handout outlining pricing for creation of magnets featuring quotes from 19th Amendment activists. Committee was formed to order magnets to sell at Convention. Committee is Linda Meloy, Terese Grant, and Nancy Halvorson.

President's Report

- LWVIA has been invited to host a round table of Women candidates for President at Drake University. Because it is strictly Presidential candidates for the Democratic caucus or Primary, MRB is concerned with the partisan aspect.
- Iowa Democratic Caucus holds a majority of women in the House
- Continue to support and encourage women to run for office. MRB gave example of woman candidate who ran for House seat and lost, but ran 2 years later and won a Senate seat. Electronic media can be positive component of campaign.
- See Yourself Here will be taken on by LWVIA to de-mystify the Capitol. Terese Grant, Nancy Halvorson and Linda Meloy will attend March 12-13, 2019 in Des Moines to observe registration and set up.

- Blueprint for Winning will hopefully be taken on by Carrie Chapman Catt Center
- Remind women representing us that they are representing us to "keep their feet to the fire" on our issues.

OLD BUSINESS

New Leagues Report

G. Wobeter reported that Sue Johannsen and Polly Horton met with Raven Hollenhorst and Chelsea Haley in Davenport. The Davenport women were discouraged that their local membership had not grown. They were advised to focus on the By-Laws and non-partisan Policy for their League, which they hopefully could find in the archives (box) at Davenport library.

Local media called upon R. Hollenhorst as a League member to speak to the Restoration of Voting Rights for felons. Myrna Loehrlein sent her documentation, and offered to do the interview. R. Hollenhorst is interested in presenting the issue in a local forum event. The Board noted that understanding the Amendment process would be important to include in such a forum. Experts on Restoration of voting rights Daniel Zeno, ACLU, and Mike Cervantes, were recommended as speakers.

MR Bragg shared that she has received inquiry from Jan Schnell about a Bentonlowa County League formation.

Bloomfield, Iowa has 17 members in the Linn County LWV, as they start their own.

Study Proposals – document for Local Leagues

P. Horton will send the form discussed to all local League Presidents. The Board suggests that local Leagues meet to discuss Program Planning and possible Study. LWVUS Convention directive was to clarify what you're doing, decide if it is reasonable to do, and define its impact.
